COVID Protocol

Technical Meeting of the Western States Section of the Combustion Institute March 21-22, 2022

To help minimize interactions between nonessential visitors and the Stanford community, visitors to academic and residential buildings of Stanford campuses are largely restricted to those approved to be onsite for education, research, and official business purposes.

All visitors need to complete the Stanford Visitor: Daily COVID-19 Health Attestation.

All visitors arriving from **international destinations** must adhere to current Stanford travel policies, please visit the travelers page <u>here</u> for more information on these requirements.

All visitors coming to Stanford must meet at least one of two criteria:

- be fully vaccinated against COVID-19
- receive a negative COVID-19 test within 72 hours prior to arrival onsite at the visitor's expense.

Face coverings are no longer required at Stanford, but are strongly recommended while indoors.

Visiting scholars, researchers, and other temporary community members with a regular presence on a Stanford campus are required to be fully vaccinated for COVID-19.

If a visitor tests positive for COVID-19, within 10 days of being onsite, they must complete the **General COVID-19 Case Reporting Form**.

Stanford Visitor: Daily COVID-19 Health Attestation

To ensure the safety and public health of our Stanford University community, visitors who have been invited to campus must attest that they have screened themselves prior to arriving on Stanford campuses, do not have COVID-like symptoms, and that they are not in a restricted status requiring isolation or quarantine. Visitors may have an academic, business, research purpose for being on campus, or may be invited to a department, school, or university sponsored event.

Visitors who do not have access to <u>Health Check</u> must attest using the <u>Stanford Visitor: Daily</u> <u>COVID-19 Health Attestation</u>, prior to visiting our campuses. **Any visitor unable to attest, is NOT approved for onsite access.**

All visitors coming to a Stanford campus must attest that they meet at least one of two criteria:

- 1) fully vaccinated against COVID-19 (required for temporary community members)
- 2) received a negative COVID-19 test within 72 hours prior to arrival onsite

Nonessential Visitors and Members of the Public

Nonessential visitors and the Stanford community are welcome to visit outdoor areas only across both campuses. Visitor parking is available in all parts of the main campus.

Visiting the university museums

The Dish area
